## DEPOSIT AND PAYMENT SCHEDULE

Check payments to be in U.S. funds drawn on a U.S. bank and must be provided by **January 15, 2025**, or upon application, whichever comes first. All credit cards are processed in U.S. dollars. The exhibitor is responsible to the general service contractor, or any other show related vendors or companies, for additional related expenses. All funds must be in U.S. dollars.

ASTRO requires payment in full no later than May 6, 2025. Failure to make payment does not release the exhibitor from any contractual or financial obligation.

If payments are not received per the payment schedule, ASTRO reserves the right to cancel the contracted exhibit space/expo suite/private meeting room/product showcase and release and resell the space to another Exhibitor and collect any amounts owed. **A five percent (5%) late fee will be assessed on amounts past due by over 30 days.**

All outstanding payments for cancellations/downsizing from prior ASTRO events must be paid in full in order to be eligible to apply and contract for space at the 2025 Annual Meeting or future ASTRO events.

### PAYMENT SCHEDULE

**By January 15, 2025:** 50% of total fee due for applications submitted on or before January 15, 2025.

**January 16, 2025 – May 5, 2025:** 50% of total fee due for applications submitted after January 15, 2025.

**By May 6, 2025:** 100% of total fee due.

**A five percent (5%) late fee** will be assessed on amounts past due by over 30 days.

## CANCELLATION POLICY

- Exhibitor may cancel without penalty provided written notification is received on or before **December 4, 2024**. If notification is not received via email at [astroexhibits@spargoinc.com](mailto:astroexhibits@spargoinc.com) by this date, exhibitor will be financially responsible for the exhibit space/expo suite/private meeting room/product showcase selected.
- 50% of the total fee plus any assessed late fees will be charged for cancellations between **December 5, 2024, and May 5, 2025**.
- 100% of the total fee plus any assessed late fees will be charged for cancellations on or after **May 6, 2025**.
