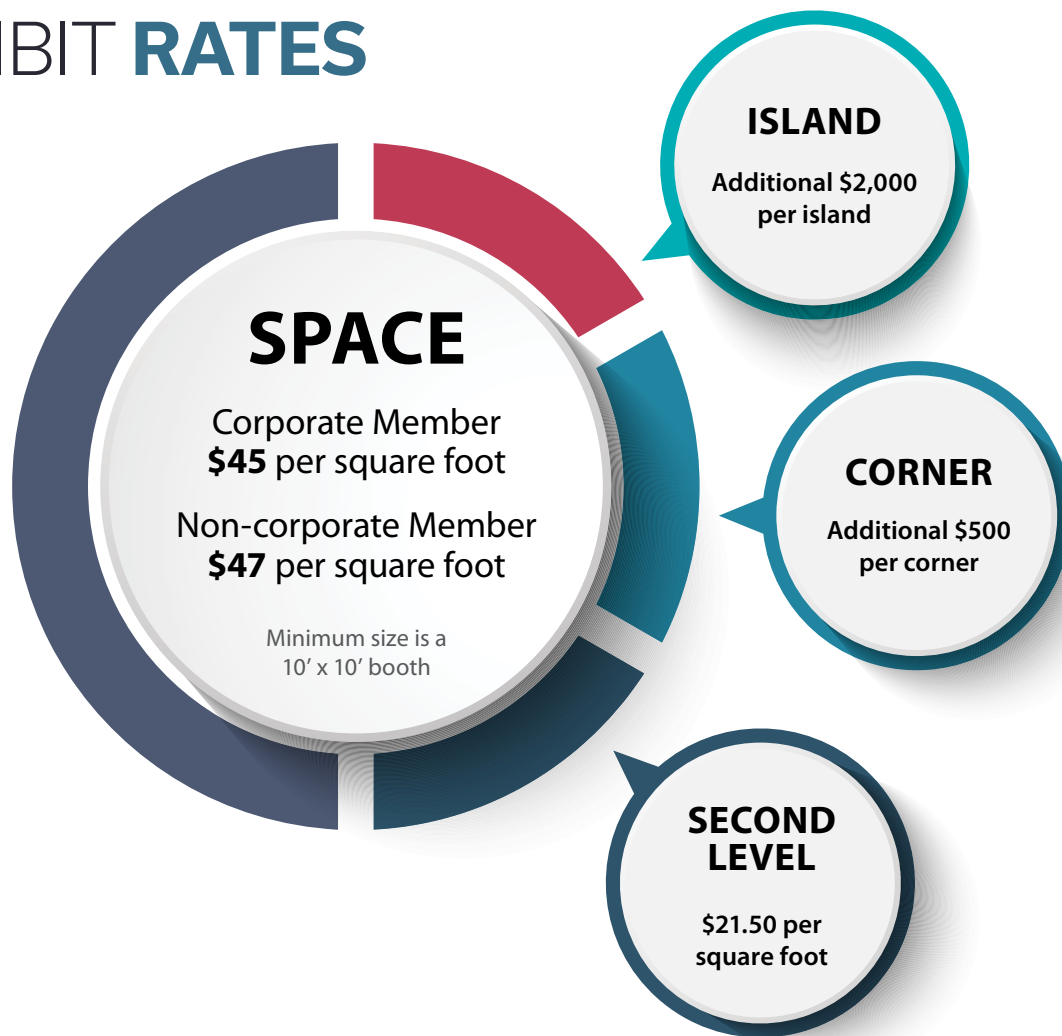


WHY EXHIBIT

EXHIBIT TERMS

TERMS OF PAYMENT

- ✓ All 2024 confirmed exhibitors are provided the opportunity to select booth space for the 2025 Annual Meeting on site in Washington, DC, during the 2024 Annual Meeting. All outstanding exhibit payments for booth, expo suite or private meeting room cancellations or downsizing from prior ASTRO events must be paid in full in order to be eligible to apply and contract for exhibit space at the 2025 Annual Meeting or future ASTRO events.
- ✓ Booth space will be held until January 15, 2025, at which time a 50% deposit of the total booth fee is due. If the deposit is not received by January 15, 2025, ASTRO reserves the right to release the exhibit space for resale.
- ✓ Exhibitor may cancel without penalty if written notification is received on or before December 4, 2024. If notification is not received by this date, the exhibitor will be financially responsible for the booth space selected as per the terms of the Cancellation Policy below. Failure to make payment does not release exhibitor from its contractual or financial obligations.
- ✓ Booth space must be paid in full by May 6, 2025. If exhibitor fails to make payment for any invoice issued by ASTRO under a signed Application and Contract within thirty (30) days from the invoice date, exhibitor shall be considered in breach of contract. In the event of late payment, exhibitor shall be liable to pay a late payment penalty equal to five percent (5%) of the total outstanding amount. The late payment penalty will be added to the original invoice and shall be due and payable upon receipt. If payment is not received per the payment schedule, ASTRO reserves the right to cancel the contracted exhibit space, expo suite and/or private meeting room and release and resell the space to another exhibitor and collect the amounts owed per the cancellation policy below.

CANCELLATION POLICY

- ✓ Exhibitor may cancel without penalty if written notification is received on or before December 4, 2024. If notification is not received via email at astroexhibits@spargoinc.com by this date, exhibitor will be financially responsible for the exhibit space/ expo suite selected.
- ✓ 50% of the total exhibit space/expo suite/private meeting room rental plus any assessed late fees will be owed for cancellations between December 5, 2024, and May 5, 2025.

- ✓ 100% of the total exhibit space/expo suite/private meeting room rental plus any assessed late fees will be owed for cancellations on or after May 6, 2025.
- ✓ Failure to make payment does not release the exhibitor from its contractual or financial obligations. All cancellations or requests for a reduction in exhibit space/expo suite/private meeting room must be made in writing and sent via email to astroexhibits@spargoinc.com.

EXHIBIT ELIGIBILITY

Rulings of ASTRO shall, in all instances, be final with regard to allowed use of exhibit space. Exhibitors may not assign, sublet or apportion to others the whole or any part of the space to which they are allocated. Only those products and/or services that are manufactured or distributed by exhibitor's company may be displayed in the ASTRO Exhibit Hall.

COMPANY MERGERS/ACQUISITIONS
